Mr. Boehnlein moved to approve the Geauga County Maple Leaf newspaper for legal notices and Mr. Hernandez seconded the motion. By voice vote, motion passed.

Mr. Boehnlein moved to authorize the Fiscal Officer to liquidate obsolete, broken, or otherwise unused Village equipment valued at less than \$1,000 per item returning any funds obtained to either the General fund or Water/Sewer funds as appropriate based on prior Council approval of the items to liquidated. Mr. Ronyak seconded the motion. By voice vote, motion passed.

Mr. Ronyak moved to approve the attendance and expenditure of funds for the Fiscal Officer, Deputy Administrative assistant, Mayor, Police Staff, and Street Staff at conferences and workshops within the state of Ohio in 2017. Mr. Hernandez seconded the motion. By voice vote the motion passed.

Mr. Boehnlein moved to approve the waiving of public reading of Council minutes for all meetings during the year. Ms. Dobay seconded the motion. By voice vote the motion passed.

Mr. Boehnlein moved to approve the minutes of 12 December 2016. Mr. Ronyak seconded the motion. By voice vote the motion passed.

Mr. Paquette asked that the minutes adopted on 24 October 2016 be amended to include the motion to adopt and approve Ordinance 2294-16. That Ordinance was completed and documented but not included in the final draft of the minutes. Mr. Boehnlein moved to amend the minutes of 24 October 2016 to include the motion adopt and approve Ordinance 2294-16. Mr. Ronyak seconded the motion. By voice vote the motion passed.

#### FISCAL OFFICERS REPORT:

Mr. Paquette presented Council with the Certification of Balances that will be forwarded to the County Auditor on Thursday, 12 January 2017. Mr. Paquette pointed out to Council that the increased carry over in the General Fund was the result of increased income tax revenue, a final inheritance tax settlement, and the refund of monies advanced to the Street Capitalization Fund. The overall result is that the Village is in a better five year projection than before, however the trend is still down as expenses exceed revenue.

Mr. Paquette offered a recap of 2017 proposed final Budget, noting that there were no changes at this time. The resolution to request an amended budget will be presented to Council on the 23<sup>rd</sup> of January.

Mr. Paquette provided a summary of open issues from 2016.

The Finnerty property at 14563 E Park will be placed on sheriff's sale on 2 Feb 2017

The Burton Fox Inn at 14656 S Cheshire has been ordered into foreclosure and will be sold at private auction.

The owners of the Gordon property have been contacted about the appearance of their property and some improvement has been made. The Fire Department is still looking to demolish the building at 13810 Spring street pending the approval of the Historical District Architectural Review Board.

There are several open issues before the police including the stop sign at Seco and Elmar, the car carrier unloading on West Center, parking on Goodwin and the AAA Safe driver course

The arborist, G-TV and fire department contracts are pending.

The Property Management ordinance, Historic District ordinance and Income tax ordinances are still under discussion

The Capital Improvement Plan for the Village has not been adopted yet.

Mr. Paquette recommended offsite storage of computer data and his preferred source is Villager Data Services. Council had no objections.

Mr. Paquette reminded Council that the Planning Commission and the Board of Zoning Appeals will meet together on 19 January with Mr. Dietrich from Geauga County Planning and on 26 January with Mr. Jemison from the Geauga Growth Partnership. Council and visitors are welcome. The meetings will be held at 7 PM in the Berkshire High School library.

Mr. T. Blair moved to accept and pay approved invoices. Mr. Ronyak seconded the motion. By voice vote the motion was approved.

## MAYORS REPORT

Mayor Koster reported that Mr. Csepi of the Street Department is resigning effective 17 Jan 2017. His position will also be advertised.

## OLD BUSINESS

Ms. Dobay and Council discussed the renewal of the G-TV contract. Ms. Dobay and Mr. Ronyak acknowledged that Mr. Jevnikar of G-TV had addressed all the concerns the Village had regarding access and coverage. The only sticking point remaining regarded access by communities not contributing funding to G-TV. Mr. Hernandez suggested that Council stipulate to Mr. Jevnikar that he attempt to gather more monetary support from those communities not currently participating but receiving the benefits. Further, Mr. Hernandez felt that G-TV should partner more with the Burton Public Library. Mr. Koster stated that outreach and education are important to getting more users. Mr. T. Blair moved to continue to contract with G-TV for local tv service. Mr. Ronyak seconded the motion. By voice vote the motion passed. Mr. Paquette stated that he would contact Mr. Jevnikar and obtain a new contract and prepare an ordinance to put it into place.
